\* This request is for a one time purchase of section of Land South ½ 22-26-34 in Finney County. This land is currently owned by family members. The request will also cover the purchase of Office Equipment. Currently **Hope Restored Christian Family Life Center, Inc.** Is housed in a room at the office of **In His Image Christian Counseling, LLC** located at 201 Laurel Street, Garden City, KS. This business has been located in Garden City, has been owned and operated by Doris Arwine for twenty three years.

Later there will be an office set up on the above mentioned land in Finney County. A water well is to be dug to establish a supply of water for the project on said property.

Grant money will also be utilized to finish paying for establishment of the (501C3) by Attorney James Dummermuth with Doering, Grisell & Cunningham, P. A. Law Firm. The Establishment of this (501C3) is in the **State Stage** and will progress to the **Federal Stage**.

On going operating costs will be generated by incoming money from billing patients Medical Insurances Plans for treatments of services that patients receive. Those unable to pay will be served from donations to Hope Restored Christian Family Life Center a (501C 3) a non profit organization.
